Scrutinizer's Report on Postal Ballot

1. The Board of Directors of Company has appointed me Barinder Singh Maur, Practicing Company (PCS No. 7041) from M/s Dayal & Maur Practising Company Secretaries by way of resolution passed at Board meeting held Wednesday, 31st March, 2021 for the purpose of conducting ballot e-voting for following resolutions as mentioned in the Postal ballot notice dated 31st March, 2021:

1.1. Special Resolution to:

- 1.1 Amendment in Articles of Association of the Company
- 1.2. Issue upto 250000 convertible warrants on preferential basis to the persons belonging to Promoter category.
- 2. I submit my report as under:

- 2.1. In view of the current extra ordinary circumstances on account of threat posed by COVID-19 pandemic situation and in accordance with Circular No. 17/2020 dated April 13, 2020 and the General Circular No. 17/2020 dated April 13, 2020 issued by the Ministry of Corporate Affairs, Government of India (hereinafter referred to as "the MCA Circular"), the Company has sent the Postal Ballot Notice in electronic form only and expressed its inability to dispatch hard copy of Postal Ballot Notice along with Postal Ballot Form and pre-paid business reply envelopes to the Shareholders for this Postal Ballot. The Company has also published notice of Postal ballot in Hindi & English Newspapers (Business Standard, Delhi Edition) on 20th April, 2021. Accordingly, the communication of the assent or dissent of the Shareholders took place through the remote e-voting system only.
- 2.2. On Monday April 19, 2021, the Company has completed the dispatch of postal notice electronically to those Shareholders who have registered email id with their depositaries and whose names appear on the Register of Members/records of Depositories as at the close of business hours on Tuesday, 13th April, 2021.
- 2.3. The Company had engaged National Security Depository Limited as (hereinafter referred to as "NSDL") for facilitating e-voting to enable the Shareholders to cast their votes electronically (hereinafter referred to as the "Remote e-voting"). The e-voting commenced on Tuesday, 20th April, 2021 at 9.00 A.M and ended on Wednesday, 19th May, 2021 at 5. P.M. The votes received electronically from the Shareholders till Wednesday, 19th May, 2021 upto 5. P.M being the last date and time fixed by the Company for postal ballot were considered for my scrutiny.

- 2.4 Particulars of all electronic votes received from the Shareholders are separately maintained for the purpose.
- 2.5. Total 40 Shareholders have voted during this e-voting.
- 2.6. The votes cast under remote e-voting were unblocked at Noida on Thursday 20th May, 2021 by Barinder Singh Maur, Scrutinizer and at the time of unblocking none was present because of Covid-19.
- 2.7. The Postal Ballot electronic votes were duly scrutinized and the shareholding was matched /confirmed with the Register of Members of the Company as on 13th April, 2021, (Cut-off date provided by the RTA)
- 2.8. The soft copy of list of equity Shareholders who voted "FOR" and "AGAINST" (None of the votes were declared Invalid/Abstain) were shared with the Company vide email dated 20th May, 2021.
